



Office Order No. 403/RTI-FAA-650

Subject: **First appeal case of Sh. Ramesh Kumar Chhabra, UDC (Retd.) Vs SPIO-cum-AE/RTI, HVPNL, Panchkula – Date of Hearing fixed on 05.07.2018.**

Proceedings before the First Appellate Authority-cum-Chief Engineer/Admn., HVPNL, Panchkula in the first appeal dated 08.06.2018 (received on 11.06.2018) of Sh. Ramesh Kumar Chhabra, UDC (Retd.) vs SPIO-cum-AE/RTI, HVPNL, Panchkula, held on 05.07.2018 at 2:50 PM.

Following were present:-

1. Sh. Chander Bhushan, SPIO-cum-AE/RTI, HVPNL, Panchkula.
2. Sh. Neeraj Ahuja, Superintending Engineer/ Admn.-II-cum-Deemed SPIO, HVPNL, Panchkula.
3. Sh. Ramesh Kumar Chhabra appellant in person.

The appellant filed RTI application dated 08.05.2018 which was received in SPIO-cum-AE/RTI, HVPNL, Panchkula office on 11.05.2018 wherein the appellant sought information **on single point** regarding status of his letter No. 29.09.2017 and its reminder dated 22.02.2018 addressed to O/o SE/ Admn.-II, HVPNL regarding 1st & 2nd ACP.

Appellant preferred first appeal dated 08.06.2018 (received on 11.06.2018) before undersigned wherein he mentioned that information has not been supplied. He further submitted that being Heart Patient, he would not be able to attend the first appeal hearing.

Accordingly, in the instant case, date of hearing was fixed on 05.07.2018 and appellant was informed vide this office memo no. Ch-2/RTI-FAA-650 dated 12.06.2018 under intimation to the SPIO-cum-AE/RTI, HVPNL, Panchkula & deemed SPIO i.e. Superintending Engineer/ Admn.-II, HVPNL, Panchkula.

In response, SPIO-cum-AE/RTI, HVPNL, Panchkula submitted his office comments vide memo No. Ch-11/RTI-4892 dated 26.06.2018 which are as under:-

1. The RTI application dated 08.05.2018 was received in his office on 11.05.2018 wherein the appellant sought information on single point regarding status of letter No. 29.09.2017 and reminder dated 22.02.2018 addressed to O/o SE/ Admn.-II, HVPNL regarding 1st & 2nd ACP.
2. Assistance was sought from deemed SPIO-cum-Superintending Engineer/ Admn.-II, HVPNL, Panchkula u/s-5(4&5) of RTI Act., 2005 vide his office memo dated 11.05.2018.
3. In response, Deemed SPIO-cum-Superintending Engineer/ Admn.-II, HVPNL, Panchkula supplied copy of memo no. Ch-16/ECP-2705 dated 14.12.2017, Memo No. Ch-55/EGS-129/BBMB dated 10.01.2018, Ch-17/CEP-2705 dated 23.01.2018, memo No. Ch-7907/CAO/Pension/10747 dated 02.02.2018 and memo No. Ch-24/ECP-2705 dated 04.06.2018 (consisting of 5 number pages) vide his office memo No. Ch-4/SEG-54/L-671/RTI-4892 dated 08.06.2018.
4. The above referred information, as received from Deemed SPIO, was supplied to appellant vide his office memo No. Ch-7/RTI-4892 dated 08.06.2018 offering an opportunity to the appellant for inspection of relevant record pertaining to his RTI application.
5. Now, the appellant filed first appeal dated 08.06.2018 with the remarks that incomplete information has been supplied.
6. The above referred appeal has been forwarded to the all concerned deemed SPIOs vide his office memo dated 13.06.2018 with the request to furnish additional/pending information, if any, to his office.

On 05.07.2018, the single point application was discussed in the presence of appellant, SPIO-cum-AE/RTI, HVPNL, Panchkula and deemed SPIO-cum-Superintending Engineer/ Admn.-II, HVPNL, Panchkula. During the hearing, the appellant stated that he is satisfied with the information supplied to him.

As appellant is satisfied with the information, as such no directions are required.

However, the appellant, if not satisfied with the decision of undersigned, he may prefer Second Appeal before Hon'ble State Information Commission, Haryana within 90 days from this order. The address of State Information Commission, Haryana is given below:-
