Subject: **First appeal case of Sh. B.S. Saroha, Advocate Vs SPIO-cum-SE/TS Circle, HVPNL, Hisar – Date of Hearing fixed on 07.01.2016.**

Proceedings before the First Appellate Authority-cum-Chief Engineer/Admn., HVPNL, Panchkula in the first appeal dated 14.12.2015 (received on 14.12.2015 through e-mail) of Sh. B.S. Saroha, Advocate Vs SPIO-cum-SE/TS Circle, HVPNL, Hisar, held on 07.01.2016 at 3:00 PM.

Following were present:-

1. Sh. Sandeep Verma, AE on behalf of SPIO-cum-SE/TS Circle, HVPNL, Hisar.
2. None on behalf of Appellant.

The appellant sought information on 8 points regarding regularization of Group C & D employees/ workers appointed/engaged on adhoc/contract/work-charged/daily wages and part time basis from SPIO-cum-SE/TS Circle, HVPNL, Hisar vide his RTI application dated 03.10.2015.

Appellant filed first appeal dated 14.12.2015 (received on 14.12.2015 through e-mail) on single point i.e. **point no. 4** with the remarks that both SPIO-cum-SE/TS Circle, HVPNL, Hisar and Executive Engineer/TS Division, HVPNL, Bhiwani have not provided the information knowingly and intentionally.

In the instant case, the hearing was fixed on 07.01.2016 and appellant was informed vide this office memo No. Ch-2/RTI-FAA-464 dated 15.12.2015 under intimation to SPIO-cum-SE/TS Circle, HVPNL, Hisar.

In response, SPIO-cum-SE/TS Circle, HVPNL, Hisar vide his office memo no. Ch-22/AA-87/A-267 dated 29.12.2015 submitted the comments which are as under:-

1. The appellant was requested to deposit an amount of Rs. 70/- as documents charges vide this office memo No. Ch.-11/AA-87/A-267 dated 29.10.2015 through Registered post but the appellant didn't deposit the same as such information was pending on the behalf of the appellant.
2. After filling first appeal, the information available on point no. 3 & 4 was sent to the appellant vide this office memo No. Ch-19/AA-87/A-267 dated 18.12.2015.

On 05.01.2016, a communication was received from the appellant through e-mail wherein he mentioned that due to ill health, he would not be able to attend the hearing on 07.01.2016 and requested to decide the appeal on merits.

As such, on 07.01.2016, during the hearing, the point number 4 was discussed as under.

Point no. 4

Under this point, the appellant sought copy of sponsorship of names of Kamla Devi, Sweeper and Ramdeen W/Carrier recommended by employment exchange or have been appointed/engaged on the basis of recommendations made by the Departmental Selection Committee, by inviting applications through advertisement against duly sanctioned vacant posts in the concerned year of regularization of their part time services, as per regularization policy applicable at that time.

Upon this, Sh. Sandeep Verma, AE on behalf of SPIO-cum-SE/TS Circle, HVPNL, Hisar stated that copy of appointment letter in respect of Smt. Kamla Devi, Sweeper and Sh. Ram Deen, Helper along with copy of regularization policy, has already been supplied to the appellant.

After hearing the views, SPIO-cum-SE/TS Circle, HVPNL, Hisar is hereby directed to certify that all the information pertaining to this point, available in the records of his office, has been supplied directly to the appellant, within 15 days, free of cost, under intimation to this office.


In addition to above, SPIO-cum-SE/TS Circle, HVPNL, Hisar is hereby directed to ensure that the requisite information supplied/ being supplied is in annotated form, legible, readable & duly certified within 15 days and compliance report be sent to this office.

The appellant is hereby offered an opportunity that he may inspect the relevant record, pertaining to his instant RTI application in the office of concerned SPIO, within 15 days on any working day, after giving prior intimation to the concerned SPIO.

Appellant, if not satisfied with the decision of undersigned or if orders are not complied with by the concerned SPIO, then he may prefer Second Appeal before Hon'ble State Information Commission, Haryana within 90 days from this order.
